Absentee Ballots must arrive at the Tribal Office by the close of business at 5:00pm on January 10, 2025.

Included with this letter you will find the following:

- An absentee ballot form with the candidates for Tribal Council and Letters of Intents for candidates running. For Tribal Council, please select only one (1) for Tribal Chairperson and only one (1) for Tribal Secretary. For Tribal Council Member at Large, please select only two (2) by marking the box next to the candidate's name.
- 2. A small interior envelope labeled: "Please Enclose Absentee Ballot and Seal".
- 3. A larger white exterior envelope (pre-stamped with postage) addressed to the "Enterprise Rancheria".

PLEASE REMEMBER THE FOLLOWING STEPS AND PROCEDURES:

- 1. Insert ballot into the small envelope labeled "Please Enclose Absentee Ballot and Seal".
- 2. Insert small envelope into larger white envelope (pre-stamped with postage) addressed to the "Enterprise Rancheria".
- 3. Seal and sign the back of your large envelope. Please note they must be in the office by 5:00 p.m. Friday, January 10th, 2025 for the Absentee Ballot to be valid. The Election Board will examine every envelope containing an absentee ballot and shall mark as having voted the name of every eligible voter from whom an absentee ballot has been properly and timely received.

From the Election Ordinance:

Section 101. Eligible Voters

(a) Eligible Voters

Pursuant to Article IX of the Tribe's Constitution, all members of the General Council who are duly enrolled lineal voting members, who have reached the age of eighteen years of age shall be entitled to vote in any legally sanctioned General or Special Election of the Rancheria.
